Respected Sir/Madam,

I am Saraswati Sikder, wife of Bibek Sikder, aged about 40 years, residing at Sarbahara Colony, Mahabirsthan, Ward No. 28, P.O. & P.S. Siliguri, District Darjeeling.

I am writing this letter to inform you that on 19/5/2025 at about 9 Received PM I was brutally assaulted by my husband Bibek Sikder along with three other persons – namely Bulti Dhali, Amal Sarkar, and Sushila Sarkar at other persons – namely Bulti Dhali stay in the day at Sarbahara Vide (XBH) Kawakhali. Bibek Sikder and Bulti Dhali stay in the house of one Hiru in e op 40E Colony, Mahabirsthan, and in the night at the house of one Hiru in MG 711 4 Kawakhali under Matigara P.S. and Amal Sarkar and Sushila Sarkar are 2.05.25 residents of Kawakhali, P.O. Shushrutanagar, P. S. Matigara, Dist. Original Darjeeling.

On that day, all of them together attacked me in a violent and Como laint To 1/CMT4 planned manner. My husband and the others punched me, slapped me, Korb ardi Far and beat me up badly. They tore my clothes, pulled my hair, and dragged Starting me around the road of Kawakhali. At one point, they took the orhni from a specific my churidar and wrapped it tightly around my neck, trying to choke me. Case land heaged them to stop but they look like I will be and there. I screamed and begged them to stop, but they kept hitting me. I truly believe they were trying to kill me. If some people nearby hadn't come hearing my screams,

All the accused persons are closely connected with each other. Bibek and Sikder is my husband. Bulti Dhali is a widow of Late Khokan Dhali. Amal Clare Sarkar is my husband's close friend, and Sushila Sarkar is Amal's wife.

They all acted together that day, and I believe they planned it beforehand. Received an 21-5-25 at 00-115-11.

As a result of the beating, my mouth was split open and my lips got badly injured. My teeth were shaken loose, and it started bleeding from my mouth, ears, and face. My left ear was hit so badly that I could no longer hear properly from one side, and later the doctor told and prescribed me that my eardrum had burst (traumatic perforation). Even now, I am in great pain and unable to eat or speak properly and the doctor has told me that I have suffered permanent loss of hearing ability in my left ear. The injuries are of a grave nature and have caused me a lot of suffering both physically and mentally.

I kindly request you to take immediate and strict action against Bibek Sikder, Bulti Dhali, Amal Sarkar, and Sushila Sarkar. I am praying for justice and for my safety as I am spending my days in utter physical and mental agony in the fear that the same assault may happen again and this time they might succeed in killing me. Please register and treat my this letter of complaint as an FIR and take appropriate steps.
