With due respect and humble submission, I would like to state that I, Rekha Rani Das (55Y/F) visited my brother's residence at Netaji Sarani Road, Haiderpara on the evening of 19/05/2025. I left for his house from my own residence ie 218 Shibomampally APC Sarani ward # 38, Siliguri (M. Corp), Rabintra Sarani, Jalpaiguri, WB 734006 at 19:00 hrs and came back at 21:00 hrs.

When I came back home, and opened the main door, I found that 02(Two) nos. of windows were broken, the grill from these windows were removed from their frame, and the lock of my almirah was also broken. The following valuable articles were missing from my almirah as well as my room which were present at their respective places when I left my home:-

- (i) 01(one) Gold chain weighing ~ 23.3 gms.
- (ii) 05(five) pieces of silver coin.
- (iii) ₹ 15,000 (fifteen thousand only) in cash.
- (iv) 01(one) golden bindi.

The total of which was worth approximately ₹ 1.5 lakh only.

In this regard, it would be very helpful for me if you can kindly look into the matter and recover these above mentioned items as soon as possible, and for that I would be for ever grateful to you.
