Sub : - prayer of initiate legal action against the illegal act of (1) Sanchita Sarkar, Daughter of Late Gouranga Sarkar (Phone : 7029781243), (2) Tapashi Sarkar, Wife of Late Gouranga Sarkar and (3) Bithi Dey, wife of Sri Suhas Ranjan Dey, all are residents of Chitrolak House, Near Goshala, Babu Para, P.S Siliguri, Dist. Darjeeling

Dear Sir,

With due respect, I the undersigned would like to inform you that, my wife Sanchita Sarkar even being my legally married wife, illegally entered into bigamous marriage with one Bapi Saha, son of Late Birendra Kumar Saha, resident of South Colony Bazar, P.S New Jalpaiguri, District - Jalpaiguri and when they were caught red handed by me and other locals, immediately we informed about the same to the O.C. NJ.P. P.S. and in the presence of one ASI Khela Murmu attached with the said police station and local people, my wife and said Bapi Saha narrated that they had entered into the marriage on 01.06.2020 and since then they are residing together as husband and wife at the residence of said Bapi Saha and upon my complaint one specific case has been started against my wife Sanchita Sarkar and her second husband Bapi Saha, her mother namely Tapashi Sarkar and her brother Shankar Sarkar being NJP PS Case no. 1309/2020 u/s 341/325/506/494/34 of I.P.C., 1860.

I would like to further inform you that since then my wife had left her matrimonial home i.e., my place in the month of June, 2020 voluntarily and deliberately alongwith her entire '*stridhan*' without any reasonable cause leaving behind me, our minor daughter namely Miss Trisha Sarkar, my old and ailing mother and living together under one roof at the residence of said address. Thereafter, I was bound to take the shelter of the Court and file a suit for dissolution of marriage under Section 13 of Hindu Marriage Act, 1955 and same is pending for disposal before ADJ, Fast Track Court, at Siliguri being Matrimonial Suit No. 257/2020 but on the other hand my wife despite entering into bigamous marriage, has falsely filed one application under the provisions of Protection of Women from Domestic Violence Act, 2005 and same is pending for disposal before the J.M. 3<sup>rd</sup> Court at Siliguri and she also got the order of interim maintenance for herself alongwith my minor daughter who in reality is residing with me at my place under my supervision and maintenance.

I would like to further inform you that since last few days, my wife is coming to my residence and unwarrantedly disturbing the peaceful lives of my minor daughter and ailing old mother and when finding no other alternative, my daughter was compelled to lodge a written complaint to the Commissioner of Police, Siliguri Police

Commissionerate on 05.05.2025 due to the refusal of the same by your concerned police station but no action has been taken till this day.

I would like to further inform you that today at around 12:30 p.m, when I alongwith my minor daughter and old mother was at my residence, my said wife alongwith her mother namely Tapashi Sarkar and her elder sister namely Bithi Dey, wife of Suhas Ranjan Dey forcibly rushed inside my house by banging my house door and all of them furiously came after me and physically assaulted me without affording me any reasonable opportunity to resist their attack by hitting me over my face and body and my wife brutally scratched my left hand in front of my daughter and mother and looking at my helpless condition when my daughter and mother screamed out of fear, my wife forcibly tried to take away my daughter alongwith her against her will from my lawful custody and when my mother tried to resist my wife, they all pushed my mother to the ground and somehow I managed to rescue my daughter and myself from their attack and in the meanwhile when the locals gathered at my residence, my wife, her sister and her mother fled away from my residence but before leaving, my wife threatened me of dire consequences that if I try to take any legal action she will send me behind the iron bars at any cost.

I would like to request you to take legal action against the illegal act of the above named persons for the ends of justice.
