

In producing herewith one arrested accused namely Sudip Sarkar (50) S/O Late Nikhil Ranjan Sarkar of 1 No. Dabgram, near Suryanagar Ground, Ward No. 23, PS- Siliguri, Dist- Darjeeling along with seized articles Viz (1) 01 (one) black coloured plastic container containing approx 30 Ltrs of Diesel (2) 02 (two) Nos of yellow coloured plastic container containing approx 30 Ltrs of Diesel each (3) 08 (eight) Nos of blue coloured plastic container containing approx 30 Ltrs of Diesel each (Total 11 plastic container of different colour containing approx 330 Ltrs of Diesel) , I SI Ganesh Roy of DD SPC, Siliguri submitting complaint to the effect that today on 17.05.2025 at 11.55 hrs received a secret source information that one Sudip Sarkar and others have fraudulently procured and stored huge quantity of Diesel illegally at their Godown at BPCL More near Jabravita traffic Point under New Jalpaiguri Police Station. They are selling the same illegally without any valid documents or license for their wrongful gain. Accordingly, I diarised the information vide DD SPC, GDE No. 113 dated 17.05.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with ASI Sushanta Dey, Const 562 Utpal Saha, Const-670 Ratan Roy, CV-151 Manotosh Talukder and CV-150 Bikash Thakur all of DD SPC left DD office at 12.05 hrs vide GDE No. 114 dated 17.05.2025 to verify the veracity of the source information.

At about 12.45 hrs we reached at BPCL More near Jabravita traffic Point and as indicated by the source, we entered into the godown of Sudip Sarkar after disclosing our identity and found that he have stored huge quantity of Gas Diesel. On demand Sudip Sarkar could not produce any document or license in support of storing such quantity of Diesel. Thus it is strong reasons to believe that he have procured and stored huge quantity of Diesel illegally at his godown by fraudulent means or by stolen means. On question, Sudip Sarkar confessed that he along with others have fraudulently procured Diesel and selling the same illegally.

Accordingly , I seized (1) 01 (one) black coloured plastic container containing approx 30 ltrs of Diesel (2) 02 (two) Nos of yellow coloured plastic container containing approx 30 ltrs of Diesel each (3) 08 (eight) Nos of blue coloured plastic container containing approx 30 ltrs of Diesel each (Total 11 plastic container containing approx 330 Ltrs of Diesel) under proper seizure list in presence and duly signed by the witnesses under proper videography and arrested the above mentioned person U/S 35(1)(b) of BNSS. I also inform him the ground of arrest. The whole process of seizure was made in between 12.55 hrs and 13.45 hrs

I therefore, request you that a specific case may kindly be started against the arrested person namely Sudip Sarkar (50) S/O Late Nikhil Ranjan Sarkar of 1 No. Dabgram, near Suryanagar Ground, Ward No. 23, PS- Siliguri, Dist- Darjeeling and others under proper section of law.
