Respected Sir,

With due respect, I Smt. Satarupa Ghosh, Advocate by profession, D/o- Sri. Ratan Ghosh, resident of- Salkabhita, Nimtala, NBU, Gate no.6, Dist.- Darjeeling would like to file a complaint against one unknown lady, who happens to be the co-passenger who got up from Darjeeling More in the same auto.

It is pertinent to mention you the whole journey – That today morning while coming to Siliguri Sub-divisional Court, I got up in one passenger auto from my local stand i.e. NBU, Gate no. 2 and after arriving at Darjeeling More the said unknown lady got up and sat beside mein an aggressive mood by pushing me and hitting me hard with her elbow, and both of us were facing the front side of the road. It's quite obvious that in passenger auto we face this kind of issue daily but this lady continuously started pushing me and hitting me through her left elbow several times on my right hand and right side of my body, to which I requested her not to do that and adjust amongst ourselves accordingly.

It is painful to mention here that the lady started abusing me with slang/filthy language and pushed me so hard that I was about to fall on the other passenger, seeing all the passengers getting disturbed by her said activities the driver and the other passengers asked her to get down in Mallaguri but she got furious and pulled my hand and started jolting my lefthand so hard that I sustained a cut on my finger and it started bleeding. I somehow assume that she tried snatching my mobile phone and purse which I carried in my left hand.

Lastly, seeing this behaviour of hers the driver stopped the auto but she being adamant refused to get down and since everyone was getting late for their respective works the driver dropped that said lady to her desire stoppage i.e in front of Hotel Heritage, at Junction at 10:50 a.m. The vehicle number of the said auto can be traced from the CCTV footage of Darjeeling More or Junction.

I therefore, inform the Police authority the whole matter and submit this complaint with the picture of the said lady that I somehow managed to click, who was not in normal human behaviour. I being an advocate had become a victim to such incident so there can be more people who can be the victim of similar incidents. Therefore, I request you to look into the matter seriously and take necessary legal action against her.
