I, Sumit Yadav Son of Baban Yadav, resident of Ganga Nagar, near Ice Factory, Jalpaimore, PS- Siliguri, Dist- Parjeeling beg to report you that I am a milkman by profession. About 10 months ago, I had purchased 03 cows from one Gosai Giri, resident of Ganga Nagar, near Ice Factory, Jalpaimore, PS- Siliguri, Dist-Darjeeling for a price of Rs. 1,67,000/-. At the moment, of purchase of the said cows, the whole amount of consideration i.e., Rs. 1,67,000/- was paid except Rs. 4,000/-. Later, about 01 months ago, the remaining sum of Rs. 4,000/- was also paid to the said Gosai Giri.

However, today i.e., on 20/05/25 at about 15:00 hrs., while I was riding my motorcycle and was passing by the house of the said Gosai Giri; at that moment (i) Kameshwar Giri, (ii) Munna Giri and (iii) Jitendar Giri all are sons of Gosai Giri along with (iv) Karan Giri son of Kameshwar Giri stopped me on my way and thereafter, dragged me into their house. Thereafter, they restrained me in her house, abused me with filthy languages, physically assaulted me causing serious bleeding injuries and forcibly snatched away my golden chain. Thereafter, they started demanding a sum of Rs. 20,000/4 by giving me life threats. Seeing such a situation when, I protested against them, and told that all the dues regarding the purchase of the cows have already been cleared, the said Kameshwar Giri threatened me by saying that I shall face dire consequences if I don't provide him with the aforesaid sum of Rs. 20,000/- by tonight.

P.S. Siliguri Metropolitan Police Thereafter, listening my hue and cry, locals came to my rescue and I somehow, fled away from the spot securing my life. Thereafter, I rushed to Siliguri Dist. Hospital where the attending doctor did my checkup and I was also advised to undergo an Xray Examination.

It is also pertinent to be mentioned herein that the said accused persons are very dangerous and politically strong individuals of our locality. And, I am in grave danger of my life. As such, it is humbly prayed before you to take appropriate legal steps against them at the earliest.
