Respected sir,

With due respect I Bidyut Roy s/o Dulal Roy residing at Hakimpara, Balai Das Chatterjee Road opposite Arunaday Sangha would like to draw your kind attention on the following effect that by profession I run a event management and digital marketing company namely The royal SS family and in this regard on January 2024 I got introduced by someone with the above named accused person Rahul Biswas and soon we became very good friend of mine. Though he also in some profession he took contractual work from me and In this regard by several times I paid him Rs. 70000/- (seventy thousand approximately) through UPI bank transfer and Rs. 40000/(forty thousand only) cash and he also told that he has an unused monitor and four pieces chair and approached me that I can keep this articles and though I have an office and need this type of articles , I also agreed with his proposal. But after passing few months some people came to my office asked payment for their work from me, then when I asked them for what reason they asked payment from me though I already clear their payment to Rahul ,they replied by saying that they did not get any kind of amount which I paid to Rahul Biswas as their payment

Then I called the accused no 1 and asked why he did not clear his dues, then he assured me by saying that soon he will clear all the dues. Then yesterday at about 8.30 p.m. he came with the above mentioned persons and without my permission took the said monitor when I try to defend them , the above mentioned accused persons hit me here and there and also broke my entire office articles not only that accused no 5 took a broken glass and try to kill me when I try to defend him sustain grievous injury on my body and they also kick me on my chest and my head , they also took some valuable articles i.e.3 ring light ,5 walkie talkie,I Pad, cash of Rs. 36000/- (approx) and also snatched a gold chain on my neck. I also mentioned here that the accused no 5 threatened me by saying that if I asked money from Rahul Biswas they he will kill me and he also told that he always carries loaded gun .Finding no other alternative I called the local police station and they and rescue me. Then with the help of my friends and relatives I went to Siliguri District Hospital. Where my treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities and give relief to me.
