Respected Sir/Madam,

I am Saubhagya Lal Singh, a retired paramilitary (Border Security Force) personnel, currently residing at Vill-Kolabari, Devidanga Bazaar, PO & PS- Pradhan Nagar, Siliguri-734003, with my family. I am writing to report a serious and concerning incident that occurred at my residence, which poses a threat not only to my family's safety but also potentially to public safety and national security.

On 21.05.2025, approx. 09:25 AM, a bullet pierced through the window glass of our living room, causing damage and creating a situation of panic and fear within my household. Immediately at aprox. 9:30 AM, I have informed to Siliguri Police control room (03532662210). Fortunately, no one was injured; however, the gravity of the incident cannot be overlooked.

Given my background in the paramilitary (BSF) and awareness of the potential implications, I believe this matter requires urgent attention. The origin and intent behind the gunfire remain unknown, raising questions of possible unlawful activity or targeted violence. I, therefore, request your esteemed office to kindly register this complaint as an FIR and initiate a thorough investigation into the matter.

The safety of my family might be at risk, and this incident may have wider ramifications, including concerns related to national security. I am available to provide any further details or assistance needed for the investigation.

Thank you for your prompt attention to this serious matter.
