With due respect, I Radha Dey (45 yrs) w/o -
Arun Dey of Champasari Anchal, Ward No- 46, PS- Pradhan
Nagar Dist: Darjeeling would like to inform you that -
today i.e. 22/05/2025 at about 20:05 hr when I was
closing my tea stall the alleged persons (i) SHRI SHANKAR
Das (ii) Rampur Das (iii) Raj Kumar Das (iv) Mala Das
and their associates came in front of my tea stall
situated at - Kadamtala near Kali Mandir, Champasari
and started beating to my son namely Vishal Dey.
When I protest them the alleged persons assaulted
physically and broken my tea stall. They used filthy
filthy languages and threatened with dire consequences.

The alleged person threatened that - to my
son "Where ever I will see your son, I will kill him".
Yesterday i.e. 21/05/2025 we have given written com-
plaint against - and today they have done same
activity upon us. As a result I and my son received
injury.

Therefore I will be very glad if you grant
my requisition and take necessary action against
them.
