I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do hereby lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that Abhishek Paul and Mamata Devi residing near Tulsinagar , Kholabakatri, P.O. MATIGARA, they have committed use of electricity illegally under section 135 (1) (e) , 138 (1)(b) and 150 of electricity Act 2003.

On dated 22.05.2025 at 16.07 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, DE & S&LP Darjeeling Regional Office, WBSEDCL 3) Lakhan Tamang , JE GR-I of Matigara CCC, 4) Sanjoy Ram of Matigara CCC have entered the premise of Abhishek Paul and Mamata Devi. During inspection it has been found that total amount of 23535.36 (OSD) as on 22.05.2025 is pending as electricity outstanding bill for consumer id 401239939 of Mamata Devi . It is also found that said connection under con id : 401239939 of Mamata Devi was disconnected for not paying electricity bill on 05.02.2025. At the time of inspection, it came to our notice that said disconnected line has been reconnected illegally without clearing outstanding dues from meter no BE0328053 CON ID : 402833936 of Abhishek Paul. Accessed load of electricity illegally enjoyed by him is 1.5 KVA. The findings are incorporated in the inspection report prepared at site.

Hence prepare an inspection memo by mentioning all minute details , as observed and also seized the meter and 2.5 sqmm pvc cable approx 10 meter in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities. The inspection team left the said premises at 16.30 hrs on date.

So it is requested that a case under section 135 (1) (e) and 138 (1) (b) of Electricity Act may please be registered against Abhishek Paul and a case under section 150 of Electricity Act may please be registered against Mamata Devi arrange for its investigation.
