Respected Sir,

With due respect and humble submission, I Goutam Prasad, aged about 64 years, S/o Late Motilal Sah, R/o Vidya Sagar pally, Near Moti Mill, Khalpara, Ward No: 07, P.O. Siliguri, P.S. Khalpara, District - Darjeeling, would like to draw your kind attention towards the following effect that I being a Senior Citizen from the past few weeks have been constantly subjected to verbal abuse, threats, and physical assault by my middle son aforesaid named Satyender Prasad and by his wife Rina Prasad, who are also currently forcefully residing in my self-owned property for the past 1.5 months without my will and permission on the pretext of forceful vigour and threat of dire consequences to kill me if I don't let them reside in the said property, moreover prior to the forceful stay to my residence the aforesaid persons used to reside at M.R. Road, Anurag Traders, khalpara. It is to be noted that the sole reason for such unwarranted behaviour and shelter in my house is only to extort money from me for his business purpose and acquisition of my property by evicting me from the said premise as because I live with my younger son namely Upendra Prasad who also takes care of me at my old age as because I am a heart patient & high sugar patient and also takes care of my wife i.e., [his mother] who is also ailing from severe medical ailments.

It is pertinent to mention that on 20.05.2025, at around 11:20 P.M. at the closure of Bedtime the aforesaid persons when I was in my room I heard the noise of breaking glass immediately I rushed in the hall room wherein I found the aforesaid person namely Satyender Prasad had wrecked the dining table and thereafter he saw me and came to me with a piece of glass of the broken dinning table in his right hand and holded my shirt and placing the glass on my neck with intention to kill me after hatched a deep rooted conspiracy with the another accused above named hearing the hue

and cry my younger daughter in law Manisha Prasad immediately rushed in and pushed me to save me luckily the broken glass fell from my middle son hand but then he started hitting me with slaps and fist on my chest resulting in immense severe pain, being totally unconscious at that moment I was lying on the floor and during this moment the aforesaid person Serial No: 02 Rina Prasad had went to my room and have opened my Godrej and have stolen Rs. 50,000/- [Fifty Thousand] which was kept from my wife treatment and some amount for business payment.

That seeing such a condition my younger daughter in law called my younger son who was then in the shop and after receiving the news my younger son immediately reached in the house and immediately took me to the Siliguri District Hospital wherein after treatment the doctor recommended me to get admitted but my younger son got me admitted in a heritage private hospital at around 01:58 A.M. dated 21.05.2025, in ICU for my better treatment seeing my condition as because I have already undergone an open heart surgery. It is also important to bring to your notice that this is not an isolated incident. There have been multiple prior occurrences of abuse and physical violence, all allegedly committed with the influence and instigation of the eldest son namely Samir Prasad (Jitender) as the sole master mind because the acts of my middle son Satyender Prasad and his wife Rina Prasad are pre planned by the active role of my eldest son Samir Prasad (Jitender), all of them have co jointly wants to acquire my property and money at dire consequences and have also told me and my younger son that they will kill us by any means either by hook or crook if we don't agree to their demands either by a road accident or by hiring local goons who will cut our heads and also my implicating me and my younger son by implicating us in a false case by any means. Moreover the aforesaid persons Serial No 01 & 02 at regular intervals used to enter in my room and used to hold me by my neck while I used to take rest and used to ask for money or else they will kill me, subsequently the same incident was repeated on 28.04.2025 whereby the aforesaid persons SL NO: 01 & 02 grabbed me by my neck and choked me and demanded 2,00,000/- [Two Lakh] Rupees, or else they will kill me and hang me by fan and also implicate my younger son in a false case, being vulnerable in such situation I gave them 2 lakh rupees, but I didn't lodge any complaint against them considering that the aforesaid persons after receiving the money will not create any problem in future. It is to be noted that on 25.04.2025 I had lodged a complaint with O.C. Khalpara, TOP Siliguri against Satyender Prasad and Others for which a specific case was started being Siliguri P.S. Case No: 265 / 2025 dated: 25.04.2025 U/Sec. 126 (2)/115 (2)/ 117(2)/ 79/ 351(2)/3(5) of BNS.

that these repeated assaults and threats appear to stem from wrongful intentions regarding the property and financial gain, with my elder and middle son and his wife attempting me & pressuring into surrendering my legal and rightful property and money in their names. It is ironic to mention that I being a helpless father at regular intervals have helped my sons with financial assistance at all possible times and now facing such behaviour from my sons and daughter in law has dismantled my mental peace and physical health.

That lastly from this said incident of 20.05.2025 night I am very deeply traumatized and was also admitted in the hospital and after my discharge from the hospital I am lodging this complaint for the appropriate legal action and relief. So kindly look into the matter and do the needful as per the provisions of law and also evict the aforesaid middle son Satyender Prasad and his wife Rina Prasad, and their children from my said residence as because I being a senior citizen is now in a continuous threat and physical assault attempt to murder that if I further stay with them for few more days my life and the life of my wife and younger son are in extreme danger.
