It is to submit that Smt. Bandi Aasha, W/o Kali Krishna, aged 35 years, belonging to the Kamma community, residing at D.No. 49-2-145, Murali Nagar Katta, Gunadala, Vijayawada. She is a homemaker and has two daughters and one son. In 2024, the complainant came into contact with a person named Alla Ramakrishna through Instagram. He is a Havaldar in the Indian Army, stationed in West Bengal. He assured the complainant that he could arrange a cook's job for her in the Army and demanded a sum of ₹8,00,000. Believing his assurances, the complainant arranged the amount and traveled to West Bengal on 20.10.2024 to meet him. Upon her arrival, the accused took her to Apurupa Lodge, Siliguri, where he sexually exploited her and took ₹8,00,000 from her under the false pretense of securing employment. The complainant returned to Vijayawada on 03.11.2024 and subsequently lodged a complaint at Gunadala Police Station. In this connection a Zero FIR in Cr.No. Cr.No.00/2025, U/s 64(2)©(m),318(4),351(2),79 BNS of Gunadala Police Station of NTR Commissionerate, Vijayawada was registered and the investigation was taken up by the SHO, Gunadala PS. It is further submitted that the scene of the offence falls within the jurisdiction of Bhakti Nagar Police Station, Siliguri Police Commissionerate, West Bengal.

Therefore, it is respectfully requested that the case may be transferred to the **Station House Officer, Bhakti Nagar PS, Siliguri Police Commissionerate**, as the offence occurred at Apurupa Lodge, Siliguri, Jalpaiguri District. which falls under the jurisdiction of Bhakti Nagar PS, for further investigation on the point of jurisdiction.
