Respected Sir,

In producing herewith one Tractor loaded with River Bed materials/Sands having Registration No. 74 BP 4429under seizure in c/w above noted case.

I beg to report that, I ASI Amal Chandra Barman of Bhakti Nagar Police station under Siliguri Police Commissionarate lodge a written complaint against the above noted vehicle to the effect that today I along with force was detailed for morning K-37 van duty Vide MCC No.2492 DT: 22.05.2025. Accordingly at around12:25 hrs while performing van duty I receive a source information that one tractor loaded with river bed materials was coming from Salugara towards Check Post Side. Myself along with C/1191 Jantindra Nath Singh and C/410 Mantosh Singh all of Bhakti Nagar PS went near check post under Bhaktinagar PS and after reaching at 12:40 hrs, I found above noted vehicle was coming from Salugara and going towards Check Post Side under Bhaktinagar PS. On seeing the police van the driver of the tractor escaped from the spot to evade police arrest. On checking the vehicle, found loaded with sand materials. Further, hence there was reason to believe that the driver of above noted vehicle and his connivance with the owner of the vehicle No. 74 BP 4429 had procured the loaded sand illegally and dishonestly transporting the same for their illegal gain from Salugara river under Bhakti Nagar PS.

On further grilling, I enquired the local people at the spot but none could answer about the said Tractorbearing No. 74 BP 4429 and they procured the river bed materials, sand illegally from Salugara River bed and carrying/transporting the same to Check Post side from Salugara river bed for his wrongful gain and without any valid document. Accordingly I informed the matter to I/C Bhaktinagar P.S and as per instruction subsequently I seized the above noted vehicle along with river bed materials under proper seizure list in presence of local witnesses and brought the vehicle to Bhakti Nagar PS. The whole process of search, seizure took place in between 12:55 hrs to13:10 hrs with properly audio & Videography.

Under the above, I pray before your kind end to start a case against the driver and the owner of the Vehicle bearing No. 74 BP 4429 and others under proper section of law and caused its investigation.
