## Dear Sir/Madam,

I Biswajit Mandal, s/o - Late Jiban Mandal, residing of Bakra Bhita, Sahudangi Hat, Nabankur Sangha, Sahudangirhat, Jalpaiguri, West Bengal -735135. Wish to lodge this complain against Shantanu Rudra who is an Ex-Employee of Shriram Finance Ltd whose branch office located at Spencer Plaza building, Bardhaman Road, Above Vishal Megamart, Siliguri, West Bengal - 734005. The said company provides financial assistance to customers and my loan being loan no - SILG12209260003 was initially look after by Shantanu Rudra when he was in service. Mr. Shantanu Rudra visited my residence on 31st March 2025 at around 8.30 AM and introduced himself as a current representative of the company and collected a sum of Rs 50,000/-from me in cash and claiming and he had spoken to his seniors and get my loan account closed in exchange for the said amount. He also tooks photographs of my house, stating that it was required for approval process, when I asked for receipt he told me that due to the end of the financial year i.e. 31st March 2025. The receipt was down and he would provide it on the next day. But after that he stops answering all my calls. I approached before the company and narrated the incident to the officials, I came to know that he resigned on 10.02.2025 and his noticed period was ending on 10.03.2025 that when the officials of the branch contact him he denied everything and also claimed that he never visited my house or took any payment from me. He even falsely stated that I was lying and there was no evidence of transactions between us.

I am a poor man and after my father passed away in May 2024 I have been facing financial problem. My widow mother and I were planning to sell our house to clear our debts for that I had collect part payment from a buyer and arranged Rs 50,000/- Mr. Shantanu Rudra contacting me since January 2025, he convinced me that if I paid Rs 50,000/- then my loan account will be closed through internal contacts. He also warned me that not to tell anyone otherwise the company will demand a larger amount for settlement purpose of my loan account. On 31<sup>st</sup> March 2025 he came to my house on a black colour bullet bike and collected the money in front of my widow mother he knowingly misused his post designation continued to represent himself as a company staff and took the said amount from me by lying and he denying everything. It is also pertinent to mention that prior to this on 15<sup>th</sup> March 2025. He had called me from **Mobile no – 8918030200** and asked me whether I had arrange any amount since this is an end of this financial year the file would be closed easily if I paid the said amount believing his words and trust him I assured him I would pay the amount before 31<sup>st</sup> March 2025.

Shantanu Rudra and initiate an Investigation at the earliest. I also request you to recover the said amount.
