Sir

With due respect and humble submission I SI Ramanath Karjee of Matigara P.S. beg to submit that on 23/05/2025 myself along with force were detailed to perform Special Raid duty, vide C.C. No. 2347/25, Dated 23/05/2025 and GDE No. 1952, Dated 23/05/2025. During my said mobile van duty, I received a source information that one Truck loaded with river bed material is coming towards Khaprail More from Bansbari side, P.S. Matigara, having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to near Barsana Hotel, under Matigara P.S. and intercepted one Truck bearing No. WB76A4345 loaded with river bed materials. On asking the driver of that Truck could not provide any valid document in respect of loaded river bed materials. It may be presumed that the Driver/Owner of said Truck procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from anywhere, for their wrongful gain and proceeding to deliver the same to their designated customer. Finding no other alternatives, I seized the Truck bearing Regn No. WB76A4345, loaded with river bed materials, preparing proper Seizure List also arrested the accused driver namely Manu Singha S/O Biren Singha of Himul, Nimai Jote, PS. Matigara Dist.- Darjeeling, informing him the ground of Arrest. I brought the truck and arrested accused to PS. Search and Seizure was made in between 21:14 hrs to 21:29 hrs on 23/05/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the arrested accd namely Manu Singha S/O Biren Singha of Himul, Nimai Jote, PS. Matigara Dist.- Darjeeling, driver of Truck bearing Regn No. WB76A4345, loaded with river bed materials, and arrange for it's investigation.
