Subject: F.I.R

Sir,

With due respect and humble submission I SI Ramanath Karjee of Matigara P.S do hereby lodge this written complaint to the effect that today on 24.05.25 I was deputed to perform special Mobile Van duty along with force, since 05.00 hrs vide Matigara P.S. C.C. No. 2349 /2025, Dated 24.05.25 and Matigara P.S. GDE No. 1973 Dated -24.05.25 in course of said special mobile van duty I received source information that one Tractor is coming from Balason River towards Bashbari Ghat under Matigara PS loaded with river bed material which were procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at Bashbari Ghat under P.S.- Matigara and found one Tractor with trolley bearing Regn. No. WB 73 E-4669 loaded with river bed materials managed to detain at near Bashbari Ghat under Matigara PS. On seeing the Police team the driver of the vehicle tried to flee away but somehow we apprehended him. On demand he could not produce any valid documents in support of said river bed materials. It is crystal clear that the driver/owner of the vehicle Tata Dumper bearing Regn. No. WB 73 E-4669 procured the loaded river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle Tractor with trolley bearing Regn. No. WB 73 E-4669 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S and arrested the driver namely Sagar Oraon (19Yrs) S/o Rajesh Oraon of Deep Nagar, P.O. Nema, PS. Matigara, Dist- Darjeeling.. The seizure was made in between 08.35 hrs to 08.45hrs on 24.05.25.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Tractor with Trolley bearing Regn. No. WB 73 E-4669 and arrange for its investigation.
