Sir,

I, Sri Parash Ghosh, 8/10 Sri Nepal Ch. Ghosh of
M. H. Sutta Road by lane, Deshbandhu Park, Ward
No. 30, P.S. Siliguri Dist. Darjeeling, beg to
inform you that yesterday (date 21/05.2025)
night at about 23.59 hrs when I was at my
house and found tenant of Sri Bisnu Deb just
opposite of my house staying at ground floor the
their building suddenly shouting and talking
loudly in verandah which causes disturbance
to neighbours as well as our concern, then
myself requested him from my bedroom window
to stop shouting or go inside your room,
at this moment he (tenant) became violent
and abusing me and calling me to down-
stairs, accordingly, myself along with my
wife had come down, in the meantime
the said tenant boy rushed to our side
and dashed me on my boundary wall
causing injury on my face again he
dragged me with an alternative intention
as because I am a heart patient as well
as senior citizen (65), seeing the fact my
tenant family friend Mr. Payne rushed to
spot to rescue me, but said tenant boy
assaulted my tenant mercilessly causing
he also received grievous injury on his
left leg.

the incident when my tenant's wife tried to
rescue her husband in the mean time owner
of the building namely (Bishu Deb) suddenly
pushed my tenant's wife with a bad intention
and malicious motive.

Therefore I request you to take legal
action against the tenant & opposite side
building as well as owner Bishu Deb.
