I Md. Rajib, s/o. Md. Ajjar, s/o. Shaktigash,
Ward No: 32, Road No - 6, P.S. NIP, Dist Jalpaiguri
would like to state that on 22/05/25 at about
11 p.m. when I was returning back from my
work and I was standing at a shop, S.F,
Road, near Fire station, P.S. Siliguri, Dist - Darjeeling
at that moment suddenly a car came (WB 79 3152)
(White colour EON) in front of me and five people
came outside of that said car, whereby I know
three of them namely ① Subrata Paul, s/o. Ranjan
Paul, s/o. Shaktigash, 11 No. Road, P.S. NIP, Dist Jalpaiguri;

Kamal Saha, s/o. Lt. Babu Saha of same
address, ③ Sahil Palit, s/o. Not known of
Teen bati Jalpaiguri and 2 others.

That the above mentioned persons come outside
with sharp cutting knives and lathis where
they all surrounded me and they all started
to abuse me in filthy language and when
I oppose them as well as when I said them
I have to go home, They grabbed me and
two of them holded my neck so that I

cannot breathe and the above named person Subrata Paul started to assault me with fist and blood and when I oppose it, they all started to hit me with lathi and by other weapons and after that they dragged me into the road and when I cried for mercy, they did not stop beating me and they beat to do death and also they tried to put knives into my chest and when I cried out loud the local people came rushing, seeing such they started to hurry and also they threatened me with dire consequences and also said that they will kill me, whenever they see me alone and they also took Rs. 6,200/- which was in my pocket, which was given to me for my work and after that they started their car and went away. Thereafter I then called my family members and went to the doctor.

It is important to mention here that the above named persons are mafia's of this local area and above named person Subrata Paul was enlarged on bail recently and I am the witness of his one of the case, that now I am spending my days in fear of them.

Therefore I came before you take legal actions against - ① Subrata Paul, ② Kamal Saha ③ Sahil Ralit and 2. others as soon as possible for the ends of justice.
