Subject: Request for Filing FIR Against Husband and In-laws for Mental, Physical, and Sexual Harassment and Dowry Demand

Respected Sir,

I, Smt. Priyanka Roy, D/o Phani Roy, residing at Ramkrishna Ashram Road, Jyotinagar, Ward No. 41, Siliguri - 734001, would like to lodge a formal complaint regarding the continuous physical, mental, and sexual harassment I have been subjected to by my husband and his family members.

On 12th June 2024, I got married to Mr. Neelesh Roy, S/o Shri Manotosh Roy, resident of Monipur Fatapukur, under Rajganj Police Station, District Jalpaiguri, before Marriage Registrar Mr. Dhananjay Sen. The marriage was socially recognized and attended by both families.

Soon after the marriage, I was subjected to continuous pressure and harassment by my husband and his family members. They demanded money from me, knowing that I am the only child of my parents. Due to emotional and mental pressure, I was forced to bring Rs. 1.5 lakhs from my parents and hand it over to my husband's family.

The harassment did not stop there. I was frequently mentally and physically abused by my husband and in-laws. My husband, Neelesh Roy, also subjected me to repeated sexual harassment. The mental trauma and abuse reached such an extent that I was driven to a state of depression and felt compelled to consider suicide.

Due to this unbearable situation, I returned to my parents' home on September 2024. After a few months, my husband came to my parental home and promised not to repeat such behavior. Believing in his assurance, I returned to the matrimonial home. However, shortly afterward, the same pattern of harassment resumed.

His parents, Shri Manatosh Roy and Smt. Mousumi Roy, along with his sister, Ms. Neelakhi Deb (residing at Eklakhi, Malda), again began to mentally and physically torture me. Ms. Neelakhi Deb even threatened me over the phone. They again forced me to bring more money from my father, leading him to sell his only property to support me.I have once again permanently returned to my parents' house in May 2025. My husband and his family came to my house to forcibly take me back, but I refused with the help and protection of SI Shri Satish Ruchel Bhaktinagar PS. My personal belongings, including clothes and jewelry, are still in my matrimonial home under the custody of my mother-in-law, Mousumi Ghosh Roy.

Therefore, I humbly request you to kindly take immediate and necessary legal action against my husband Neelesh Roy, his father Manotosh Roy, his mother Mousumi Ghosh Roy, and his sister Neelakhi Deb for the physical, mental, and sexual harassment, dowry demand, and threats to my life and dignity. I seek justice and protection for myself and my family.
