Respected sir, I Subnum parveen w/o, Sk. Samjad Ali residing at Malda, presently resident at sushrutanagar, near NBMC&H, Siliguri, would like to bring to your knowledge that upon the request of my eldest sister Shama praveen to resolve the personal issue between me and my husband Sk. Samjad Ali mob. 8001187986 and asked to visit at Ranjit kumar shrivastav's mob. 9434045072 flat at Amrapali apt. Flat no. A5 near donbosco more, where my eldest sister Shama praveen mob. 9140465693, live as his mistress. I had visited along with my younger sister Tarunnum parveen. I went outside their flat and main gate was not locked, as I opened the gate, I saw Sk. Samjad Ali and Shama Parveen were fully drunk and were sitting on sofa in compromising situation. Seeing that I could not control myself and I started yelling and tried to enter the flat, but suddenly they both along with my brother who was hiding inside another room Md. Khalilullah Sheikh mob. 6295994866 started pushing me out of the gate and twisted my hand severely. Both Sk. Samjad Ali and Md. Khalilullah Sheikh started hitting on my chest with fist and blows and tore my clothes, using abusive and filthy language to me and my younger sister, and they attacked us using chilly spray. Even they were threatening us that they will commit us into a gang rape and make our life hell. I dialled 100 to call the police and police came after 15 minutes on the spot namely Passang sherpa, mob. 8637594149, in the meanwhile local public gathered and controlled the situation and saved us from them. Even I have voice recording of my brother Md. Khalilullah Sheikh and Shama praveen talking to my husband Sk. Samjad Ali to divorce me and falsely saying about my character and giving idea how to hack my phone and snatch my only child.

As I was very serious and needed instant medical treatment and I could not breathe properly so I have admitted in NBMC&H for further treatment because I was fainting again and again due to mental trauma of what I have faced. Again they three had come to the NBMC&H at around 2am and threatening me in a silent voice not to register case in P.S. and even they were threatening to the on-duty doctor not to make serious injury report.

Sir, Several cases are pending against Sk. Samjad Ali and Md. Khalilullah Sheikh and Ranjit kr. shrivastav in NJP P.S. F.I.R NO. 16/25, DATED 11.01.2025, 17/25, DATED 11.01.2025, 100/25, DATED 17.02.2025, 188/25, DATED 23.03.2025, 246/25, DATED 12.04.2025, 254/25, dated 17.04.2025 and they are not afraid of law and order and many times my brother Md. Khalilullah Sheikh and Sk. Samjad Ali has attempted killing me and my younger sister tarunnum parveen.

Please take strict action against them and booked them as per law of relevant section of b.n.s.
