Sir,

It is to inform you that I, Bijay Lakra, S/O Bernard Lakra, DE(S&LP), Darjeeling Region ; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **BISWAJIT DE SARKAR, S/O- MANAMAD DE SARKAR & NARAYAN DEY SARKAR, S/O- MANAMAD DE SARKAR** of Vill-Samarnagar, P.S-Bhaktinagar, Dist-Jalpaiguri, Pin-734003 for illegally & unauthorizedly extending electric supply to a temporary disconnected domestic premises having pending dues and abetting the offence respectively.

Today i.e on **23.05.2025**(13:49 hrs), I came to Samarnagar, P.S Bhaktinagar, Dist-Jalpaiguri; in my official hired vehicle for a routine inspection. I was accompanied by (i)Bhaben Roy, SO(S&LP) CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter **L1251573**(Consumer Name-Biswajit De Sarkar, Domestic Category, Con Id-400015040) is illegally & unauthorizedly extending electric supply to temporary disconnected premises of **Narayan Dey Sarkar**(Domestic Category, Con Id-412103978 Disconnection-04.12.2024, OSD-Rs.5040.47, LPSC-Rs.487.49 as on 23.05.2025).

I disconnected the connection of **Biswajit De Sarkar** & seized the meter **L1251573**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- i. 1 phase energy meter **L1251573**, 240V, 5-30A, Make- Landys Gr (L/R-5832)

Biswajit De Sarkar was not present at the premises. The Notice, Inspection Sheet & Seizure list were received by his son **Samarjit De Sarkar**.

As such, **Biswajit De Sarkar**, extended electric supply to a temporary disconnected domestic premises(illegally & unauthorizedly) and is liable for prosecution U/S **135 1(e) & Narayan Dey Sarkar** is liable for prosecution(for abetting the offence) under section **150** of Electricity Act 2003. Hence, you are requested to treat this as FIR.
