I, Smt Rimpa Adhikari Tirkey, W/O Shri Amrit Lal Tirkey , age about 35, by occupation house wife , present address- Madhya Shanti Nagar, near Saint Xaviers School, P.O. Dabgram 2, P.S. Bhakti Nagar, Dist. Jalpaiguri, PIN: 734004, beg to state you that my marriage salmonized on 20th December 2021 with Shri Amrit Lal Tirkey (ph. 7001025767,8927966661), at Assam which is my parental address under Hindu rites and customs. After marriage we started to stay together at our present address which is a rental house. After two or three months of my marriage my husband started to torture me physically and mentally. Day by day it's became intolerable for me. It's more than 3 years of our marriage but not a single day left that he doesn't torture me. Several time he try to kicked out me from the house. Every day He creating pressure on me for divorce. He has extra marital affairs with a lady. He spends time with that lady in our rental home in my absence. Last 5 months I was in my parental home due to my father's illness. When return to our rental home I became to know, from my landlord that my husband and a lady stay together at our rental home. After knowing the fact when I protest last night, and asked about the truth my husband without any reason started using filthy languages upon me and when I defend him ,he without any reason beat me and kick me here and there as a result I sustained privious injury on my body, not only that he took a sharp

weapon and try to kill me, finding no other alternative when I started shouting my husband fled away. He also told at the time of leaving the house that If I stay here he will kill me . Then somehow I went to Siliguri District Hospital where my treatment is going on.

I, therefore, request you to please accept my written complain against my husband Shri Amrit Lal Tirkey and please take proper legal action as soon as possible and give protection to me as because I am a helpless woman. My parental home is in Assam. I don't have any friends or relative surrounding me. I will be highly obliged if you take necessary action in favour of me.
