Accordingly, the information was diarized vide D.D SPC GDE No-. 161 Dated 24.05.2025 . As per order of ACP, DD, SPC, myself along with Inspr. Abhijit Dutta, Inspr Kajal Sarkar, SI Biswajit Ghosh, SI Ganesh Roy, ASI Sushanta Dey, Const. 562 Utpal Saha, LC- 1332 Jayanti Oraon and LCV-858 Babli Biswas all of DD,SPC left for City centre Vide GDE NO 162 Dt. 24.05.2025 to verify the veracity of information. On arrival at City Centre, I requested available local independent witnesses namely (i) Bijay Roy (22) (Ph. No 75479952841) S/O Nirod Roy of Gondogol Jote, Panitanki, PS- Kharibari, Dist- Darjeeling and (ii) Siddhart Lohar (19) (Ph. 9883345718) S/O Sagar Lohar of Chiloni Tea Garden, New Line, PS- Meteli, Dist- jalpaiguri to remain present during the time of raid, search and seizure if any. Subsequently, we proceeded into the shop styled as "ADORE" Unisex Salon at the basement of City Centre and, seeing the Police party some of the people and the lady staffs of the SPA who were outside the shop fled away. Then we entered into the SPA, and found reception counter and one small room made for customers for sexual act and also found that the said room of the SPA was under lock from inside. Then we knocked the door of the room and when opened, found accused noted in SI, No (i), and (ii) inside the room in an objectionable position (i.e almost nude) and were involved in sexual activities. Seeing Police presence

hurriedly put on their clothes. With the help of lady Police, the girl was separated from the male accused person.

On interrogation, they disclosed their identity as noted above and the lady accused admitted that she herself running the business of prostitution and earn money by engaging herself in illegal prostitution. She further revealed that they were carrying the business of prostitution under the camouflage of Body massage for their monetary benefit and also admitted that they meet up the urged of customers by demanding extra money and provide them Accordingly, we searched the "ADORE" Unisex Saloon in presence of independent witnesses and found (i) One used Condom (ii) Two Torned packet of Condom (iii) one empty packet of Kamasutra Condom from the room of "ASORE" SPA. Accordingly, I seized the same under proper seizure list in presence of witnesses. Subsequently, Larrested accused namely (i) Md Saruk (29) S/O Full Mahammad of Dhum Dangi, PO- Haptiagachh, Jhajhri, PO- Haptiagach, PS- Chopra, Dist- Uttar Dinajpur, and (ii) Rita Roy (F/28) W/O Ashim Roy of Dhapganj Purba Baruya Para, Garalbari, PS- Kotowali, Dist- Jalpaiguri u/s 35 of BNSS observing all formalities. The female accused was arrested maintaining all dignity and decency. I also inform them the ground of arrest. The whole process of search, seizure and arrest was done in the presence of Sri Debasish Bose, ACP, DD, SPC. The seizure was made in between 13.15 hrs to 13.55 hrs in presence of witnesses.
