I have the honour to inform you that on 24/5/25 at about 6:40 pm when we were approaching towards Bidhan market through Venus more, then suddenly the above named miscreants Shoaib Sahadat s/o Sahadat Hussain ~~to~~ residing in Torpurkhuri near Royal feed Hatchery P.O. Saudangi, Siddique Sahadat s/o Sahadat Hussain address block II 4B Shantiniketan apartment near alphonso school Medical. Subnum Parveen @ Shantiniketan Apartment block II 4D, w/o Samjad Ali, Tarunnum Parveen w/o Rahul Singh block II 4D Shantiniketan Apartment, Tabassum Parveen wife of Siddique Sahadat @ Shantiniketan Apartment block II 4D, Irfan Ali Dongipara, Aqib Dongipara ~~an~~ being foreplanned attacked upon us and damaged the car of my brother bearing vehicle no WB-24 A K 8878. That on being foolish the above named miscreants assaulted us on our person and outraged my modesty by molesting me and touched my private parts and broke my ring finger left hand. Miscreants also assaulted my brother brutally and tore his wearing apparel. They threatened us with dire consequences and abused us in filthy languages. It is pertinent to mention that on 22/5/25 the above named miscreants had been to my apartment and created nuisance and criminal assault upon us
