I Gubnam Parveen, wife of S.K. Samjad Ali presently resident at Thikrikata, P.O. Shushon-nagar; P.S. Medical Outpost (Matigara); Dist. Dajearing; P.N. - 734012, would like to state that one Md. Khatilullah Sheikh, Son of Habibullah Sheikh; resident of Annapally Apartment flat No. A/5 near Don Bosco School P.S. Bhaktinagar, Dist. Jalpaiguri (WB), was my brother by blood. There were odd relations between me and my brother as such my brother has also been a nuisance for me since long ago. On several occasions he tried to stalk me whenever I visit to my place which he came to know. At same happened today, on 24/05/2025, when I was appointed to my doctor for treatment, I was moving on the ~~main~~ hill road, at Venus more, I was hit by car bearing number WB 24AK 8878 mercilessly.

After the Incident that was sudden happened, I made senseless and was carried by bystander to the hospital. At the same time my belongs family member came to spot and visited there. After hearing when public gathered, it was come to my knowledge that my brother has also injured (i) Sohail Shahadat, son Shahadat (M/N- 8250559190) and (ii) Raja Saha, son of Gobindo Saha (M/N- 7557872470). When the nearest traffic police personal came to spot it out, they were also be hit by my brother, namely Md. Khalilullah Sheikh, son of Habiullah Sheikh. It is pertinent to mention that the intention of my brother toward me was malafide and he has been continuously passing flung language ~~be~~ also toward me on my character. After this incident, he has also threaten me over phone as well as at police station to kill me whenever he get opportunity.

Hence, it is my humble Submission that before your august officer/authority that the offender shall be punished by due the process of law.
