Sir,

I Bibiana Chetui, D/o Mr Andrew Chetui, Age 30 years, resident
of A3, Vrindavan Apartment, Kheprail Road, Matigave, Siliguri, Pin 734010,
would like to report that on 17.5.2025 and 18.5.2025, I got the
advertisement via Instagram, where I had to enter my contact number
that is 9593227318 and after a few minutes I got a whatsapp texts
from 9675841898, I then started following his lead, thinking I will
make little money just by giving review in hotels and restaurants,
then this person gave me a code to submit via Telegram app, and
then they told me to transfer the amounts and that I will be
getting back higher rate in 20% to 30%, on 17.5.2025 Rs 3,000,
Rs 2,000, Rs 1,000, Rs 2,000, Rs 12,000, Rs 40,000 and on 18.5.2025
Rs 11.2k [2 times], 11.2k and 60,000 from different account, I had
to transfer them in various given amounts/accounts, to which
I have brought the copy. I have done these payments from apps -
imobile and googlepay. I kept on transferring them the money
so that I don't lose my previous amounts. Still I did not receive
back, I have submitted all the proof papers of my money
transfer in those accounts. Total of Rs 4,40,000 [Four lakhs, forty
thousand] has been scam. Rs 11.2k has been deducted from my
friends account, to which I have submitted all the details, too.

Therefore, I request you to take the necessary steps.
