I Smt Laxhi Devi, wife Mani, now residing
resident of Champasari, Anchal, at IT-
Computer Gali, Ps. Pradhan Nagar, Dist-
Darjeeling would like to report you
the following facts:-

① That yesterday night i.e. 23.5.25 at
about 10.30 Pm ① Jivam Prasad, s/o.

Sudhir Prasad, his mother ② Sarita Prasad
wife of Sudhir Prasad along with their one
relative (Bhanja), near our house started
abusing my son in filthy and offensive
language. Seeing this my son protested them,
at that time they became more furious
and violent and started assaulted
my son by fist, blows and by kicks,
seeing this my son started raising hue
and cry and having in cry -

I came out from my house and rushed to save him. Seeing this said Jivan Prasad his mother Sarita Prasad and his Bhanja started physically assaulted me. They tore my wearing apparels with intention to outrage my modesty. They snatched one gold chain from my neck weighing 01 bhari.

It is to be mentioned here that said Sarita Prasad his son Jivan Prasad occasionally we threatened me and my family members of dire consequences they we demanded Rs. 10 lacs from us.

Sir, in the month of December 2023 we took loan of Cash Rs-2 lacs for my husband's treatment, and we repay this loan amount with ~~the~~ interest. But inspite of that they are continuously threatened us.

Sir, said Jivan Prasad with intention to kill my son attacked him with knife, but my son avoid such war of his

As a result my son got severe
cut injury on his right hand's
finger and we went at Siliguri
Dist. Hospital and we are under
treatment now.

I, therefore, request you to kindly
take necessary legal action against
said Jivan Prasad his mother
Sunita Prasad and his relative.
