With due respect I, Subnum Parveen W/O. SK. Samjad All resident of Matigara, Siliguri, Dist.-Darjeeling, West Bengal, Pin -734011 would like to bring to your kind information that on 22-05-2025 around 10.00 pm I had visited along with my younger sister Tarannum Parveen upon the request of Shama Parveen (9140465693) to resolve the personal issue with my husband SK. Samjad All and she asked me to visit their Flat A5, Amrapali Residency, near Don Bosco More, Siliguri, West Bengal of Ranjit Kumar Shrivastava (9434045072) and she is living with him as his "Mistress" and belief upon herself me and my younger sister Tarannum Parveen had visited to the flat where Md. Khalilullah Sheikh, Shama Parveen and SK. Samjad All all were in drunken state and there my husband had started abusing me using filthy languages upon my character and when I opposed against his abusive behaviour then Md. Khalilullah Sheikh (6295994866) had twisted my wrist, pushed me on the sofa and Shama Parveen had grabbed my neck with full arrogance and severely hit on my chest with blows and fists and tore my clothes with the criminal intention to murder me and I was lying in unconscious state and for my protection my younger sister Tarannum Parveen had come forward then SK. Samjad Ali had forcefully restraint her and physically assaulted my younger sister and after hearing the noise the other members of the apartments reached there and saved our life and informed the police control room by dialling "100" and within 15 minutes the police officer namely SI Pasang Sherpa (8637594149) reached there and rescued us and duly informed our family members and helped us to get admitted to North Bengal Medical College & Hospital (NBMCH) as I was very serious and needs immediate medical treatment and facing breathing problems and severe pain in my chest and after getting admitted to the North Bengal Medical College & Hospital (NBMCH) again at late night ^{around 2 AM} Md. Khalilullah Sheikh, Shama Parveen, Sk. Samjad Ali came with some goons and entered illegally in the "Surgical Casualty Ward" where I was admitted on Bed No. 18 by taking the undue advantage of being a doctor and ex-student of the medical college and hospital Md. Khalilullah Sheikh had started threatening me not to lodge any FIR against them otherwise being a doctor it could be easier for himself to inject the slow-poison injection to my veins and talking about to sale my organs to other medical organizations and somehow I was managed to escape from the ward to the corridor for help as I could not be able to shout due to the medical reason where he had followed me and grabbed my neck and forcefully pushed my head to the wall and due to which I am going through the mental trauma and feel unsafe as my life is in endanger and still I am getting life ending threats and feel unsafe.

And, it is important to mentioned here that and it was a pre-planned criminal conspiracy of Ranjit Kumar Shrivastava, Md. Khalilullah Sheikh, SK. Samjad Ali and Shama Parveen to murder me as they are very dangerous and can go beyond the limit to finish my life also I had recently filed a complaint on 05-05-2025 to the "The Commissioner, Siliguri Police Commissionerate, Siliguri" against Ranjit Kumar Shrivastava and his involvement in several unlawful activities and so many FIR's had been registered at New Jalpaiguri Police Station against them for committing serious heinous crimes which were as listed below :
