I, Dr. Biswabandhu Saha, son of Late Biswambar Saha, Resident of Children park, Siliguri, Dist- Darjeeling, do hereby lodge this FIR on the following effects with the request for taking immediate action:-

- 1. That I am a doctor by occupation working as Radiologist and since long years I have involved myself in carrying on my profession through a diagnostic centre under the name and style as BBS Mediscanners at Children Park, Siliguri and by virtue of my efficiency and effort, I have achieved a certain reputation and thus by virtue of my reputation and my diligent duties, the people started to trust me as a high level dependable Radiologist and thus bear a good reputation in society in Siliguri and West Bengal since last 25 years.
- 2. That due to my business, I came across a good number of people and out of them some people are well known to me, It is pertinent to mention here that in the month of November 2022, one Mr Bhajan Kumar Das, (Mob 7098383744) s/o Late Subal Kr. Das & Bhakti Das, resident of Anushka Apartment, Aurobinda Pally Main Road, Subhash Pally, Under SMC Ward No. 19, P.O. & P.S. Siliguri, Darjeeling, Pin 734001, with certain

reference met me for starting a new project of hospital specially for Neuro, Ortho and Trauma patients and requested me to help them to set up their business and at the same time they had also requested me to be a partner of their proposed business, which I had flatly refused, as I remain awfully busy in managing my diagnostic centre and thus there was no scope on my part to accept the proposal of Sri Bhajan Kumar Das. I also state that Sri Bhajan Kumar Das s/o Bhakti Das subsequently introduced Sri Apurba Roy husband of Smt. Sharmila Ray, Resident of Palki Apartment, Ashutosh Mukherjee Road, Subhash Pally, within Ward No. 19 of SMC, P.O. & P.S - Siliguri, District - Darjeeling, Pin - 734001 as his partner and again requested me to be a partner of their proposed business disclosing that they were both (that is Sri Bhajan Kumar Das & Sri Apurba Ray (Mob - 9475245850) were/are Government service holders and thus that they cannot be involved in running any business directly in their names and as such they had determined to run one proposed hospital cum diagnostic centre through Smt. Sharmila Ray (Mob - 8158808616) (w/o Sri Apurba Ray) and Smt. Bhakti Das (m/o Sri Bhajan Kumar Das) as direct partners.

3. I further state that despite repeated refusals to the proposal of Sri Bhajan Kumar Das & Sri Apurba Ray, the said two persons did not keep silent, rather started to pursue the proposal so as to convince me and to help them to establish and run their contemplated hospital business and after several approaches I had been compelled to accept the part proposal of the business in which they agreed to purchase my running machinery relating to hospital & diagnostic business, which I had installed in my existing business namely "Greenage Hospital" and after that the said two

persons through their expert visited my machinery, inspected and enquired regarding its working capacity and value together with other aspects in presence of certain witnesses and after having been satisfied they had agreed to purchase my said machinery at Rs. 98,32,901/-(Rupees Ninety Eight Lakh Thirty Two Thousand Nine Hundred and One) only but requested me to allow certain time to clear the entire purchase amount by way of installments and according to terms of this verbal discussion the said two persons prepared one document for establishing the said hospital through the Hospital Clinical Establishment License (CE License) and accordingly the said two persons prepared documents as partnership showing Mrs. Sharmila Ray and Smt Bhakti Das as partners and also shown my status as partner which I had objected but the said two persons told me that if my status is not shown as partner, they will not be able to get any permission from the authority to run the said business and moreover, assured me that the said two persons will bear the full responsibility and liability to run the business and also assured that for providing the entire machinery set for their project, the entire payment of those machineries will be paid in four installments and within four months from the date of installation and in terms of the said discussions, I installed the entire setup in the business place situated at Asian Highway, Tinbatti, Siliguri 5 under the name and style of BBS Seba Hospital in December 2022.

4. That I was assured to receive in four equal installments cash of which is Rs. 24,58225 (Rupees Forty Lakhs Fifty Eight Thousand Two Hundred and Twenty Five) and but till date even after installation of same in the business place I did not get any sorts of payments despite repeated
