With due respect and humble submission, I Mrs. Sujata Gurung, W/O Mr. Pramit Lal, R/O Ankita Residency Apartment, near Basundhara Garden, Dagapur, Gyanjyoti More, P.S Matigara, Siliguri, Dist Darjeeling, would like to informed you that my marriage was solemnized with my husband Mr. Pramit Lal, on 22.05.2004, according to Hindu rites and custom. Now my husband is posted at Gospukur Rang Office, Kamla Bagan, Ghospukur, P.O & P.S Phansidewa, Dist Drajeeling, designated as Forest Range Officer. After that I gave a birth a female child namely Silvasha Lal on 17.03.2005. Now with deep sorrow I would like to make a prayer to you regarding my husband and our marital relationship. Since I gave birth a female child my husband and my mother in-law used to torture me mentally and physically, they both always used to abused me and filthy languages, and threatened me with dire consequences if I will not gave birth to a male child then my husband will marry to another women. And I am from Nepali community, therefore, my husband and Mother-in-law always saying me that we are very bad behaviour, we belongs from hills, and we are no manner to how to speak, how to dress up and my husband told me if he marry with their community's girl then he would get dowry and cash, and all this. My husband always abused me, sometimes by Kick and blows, and sometimes slapped me in front of others. That my husband say me that our female child is useless for himand forced to born to male child, he never talked with our female child in good manner, he never pampered her. Several times I wanted to compliant against my husband and mother in-law, but due to keeping in mind his position, and reputation of his, and his family, I never compliant against them.

That after 17 years of my First daughter, for the sake of my husband and for happy family, I tried for make a baby, and again I gave birth a female child on 09.10.2022, namely Silvana Lal. Since then my husband and my mother- in- Law, they both started mentally torture on me and my elder daughter, they says I and my both daughters are useless, I never able to give birth a male child. Then my husband developing extra marital affair with a lady namely Deepa Chhetri, D/O Mr. Puran Chhteri, of Hasimara Bazar, Hasimara, Alipurduar (8250844818). When I knew about affair of my husband, then I talked with that lady and told that he is a married man having two daughter, then the lady started threatened me that if my husband will not marry with her then she will attempt suicide. And my husband also told me that if I will not accept their extra marital relationship then either he kill me and our daughters or else he will

attempt suicide, That my nusoand threatened me that ne would get married to someone who can give birth to a son.

That on 08.04.2025 my husband called my eldest daughter and said he wanted to talked to me, when I took the call he abused me in a very bad languages, and threatened me with dire consequences as well as he will teach me a lesson if I will take any legal action against him and that lady Deepa Chhetri, after that several meetings were done between my family, in-laws, husband, and that lady namely Deepa Chhetri and her family, but it didn't work, all my husband's office staffs also known regarding this all matter but due to fear of position of my husband they will not stand for this, now I totally hopeless my husband aggravated to such an extent that I was physically, mentally and verbally mercilessly abused everyday without any rhyme and reason. Therefore I have no any alternate, I am stayin with my 2(two) daughters, under threat and immense mentally pressure and torture by my husband and mother in-law namely, Sona Devi Rajak, W/O Late Madan Lal, I came before you kindly take a legal action against my husband, my mother -in -Law, and that lady namely Deepa Chhteri, and help me to get justice, and I shall be grateful to your kind cooperation.
