Subject: Filing of FIR for Violation of Court Order and Illegal Trespass

Respected sir,

I Swapan Saha, son of Dhirendra Nath Saha, permanent resident of Ghoglomali main road ward No 37 of SMC p.o Rabindra Saran, P.S. Bhaktinagar Dist jalpaiguri wish to lodge a complaint against Uttam Haldar son of Bimal haldar and Mithu mandal son of birat Mondal (land grabbers) for wilfully violating a court order and committing illegal trespass into my property

Details of incident.

- That I am the lawful owner of land measuring about 4 katha 11 chattak under L.R. Plot no. 323, recorded in L.R. Khatian no. 527 and 526, Sheet no. 3, under Mouza Binnaguri, P.S. Rajganj (Old) (Now Bhorer Alo), Dist. Jalpaiguri
 - 2. That there exists an injunction / restraining order passed by the Hon'ble Civil Judge Junior division jalpaiguri in Title suit no 310 of 2025, Order dated 06/05/2025, which prohibits the accused from interfering with my peaceful possession and from encroaching any portion of my land mentioned above.
 - 3. That on 23/05/2025, at around 7 pm, the accused, namely Uttam Haldar son of Bimal haldar and Mithu mandal son of birat Mondal, in blatant disregard of the court order, illegally entered the premises by breaking the lock and are trying to construct a brick wall in my property in order to occupy my land. it is permanent to mention here that the accused persons had tried to commit a similar act on 08/05/2025 and I had lodged a complaint on 10/05/2025 to that effect in your station but no action has been taken against the accused persons till date.
 - 4. This act of trespass and violation of a judicial order is not only contemptuous but has caused me mental harassment, fear, and insecurity.
 - 5. Despite my repeated requests and warnings about the existing court order, the accused persons are adamant and have continued their unlawful behaviour.

Legal Violations:

I believe the following sections of the B.N.S are attracted:

- Section 223 Disobedience to order duly promulgated by public servant. (for violation of court order)
- Section 329 Criminal trespass
- Section 329 (3)—Punishment for criminal trespass
