Sir.

With due respect and humble submission, I SI Mrinal Basunia of Matigara P.S, SPC do hereby lodge this written complaint to the effect that today on 26.05.2025 I was deputed to perform Special Raid duty along with force vide Matigara P.S. C.C. No. 2375 /2025, Dated - 26.05.2025 & Matigara P.S. GDE No. 2108/25, Dated - 26.05.2025. At about 21:10 hrs, in course of said Van duty I received source information that one vehicle Tata Truck bearing Regn. No. WB - 71 A-0624 loaded with river bed materials is standing near Sutki Godown under PS-Matigara which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to the spot and found one vehicle Tata Truck bearing Regn. No. WB - 71 A-0624 loaded with river bed materials standing near Sutki Godown. On demand the driver of the vehicle could not produce any valid documents in support of said load. It is crystal clear that the driver/owner of the vehicle Tata Truck bearing Regn. No. WB - 71 A-0624 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain.

Finding no other alternatives, I seized the said vehicle Tata Truck bearing Regn. No. WB -71A-0624 loaded with river bed materials under proper Seizure List under coverage of Videography also arrested the driver namely Kartik Roy (31), S/O Phubundu Roy of Parimal Nagar, PS- Matigara, Dist- Darjeeling and brought the seized vehicle at P.S. The seizure was made in between 21:25 hrs to 21:30 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver namely Kartik Roy (31), S/O Phubundu Roy of Parimal Nagar, PS- Matigara, Dist- Darjeeling and owner of the seized vehicle Tata Truck bearing Regn. No. WB - 71 A-0624 and arrange for its investigation.
