With due respect, I am producing herewith the 03 (three) arrested accused persons namely (i)- Mustak Alam @ Alex (19) S/O late Tafjul Rahaman of Jhar Bari, Chopra, P.S. Chopra, Dist. Uttar Dinajpur (2)- Md. Alim @ Ali (20) S/O Mofiz Alam of Lelin colony, P.O. & P.S. Matigara, Dist. Darjeeling and (3)- Bishal Das @ Rahul (20) S/O Suman Das of Matigara, Beldangi, P.O. & P.S. Matigara, Dist. Darjeeling along with the following articles under seizure :-

- (1)- One iron dye measuring approx. 1.5 feet and One Cheni from the possession of Mustak Alam @ Alex (19) S/O late Tafjul Rahaman of Jhar Bari, Chopra, P.S. Chopra, Dist. Uttar Dinajpur.
- (2)- One iron hammer and one torch light from the possession of Bishal Das @ Rahul (20) S/O Suman Das of Matigara, Beldangi, P.O. & P.S. Matigara, Dist. Darjeeling
- (3)- One Iron made sabol approx. 3 feet from the possession of Md. Alim @ Ali (20) S/O Mofiz Alam of Lelin colony, P.O. & P.S. Matigara, Dist. Darjeeling.

I, ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 28.05.2025 at 00:05 hrs. received a secret source information that some miscreants were assembled on vacant land at opposite SJDA Office, Himachal Vihar under Matigara P.S. jurisdiction with deadly weapons and making preparation for committing dacoity at Himachal Vihar area under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and as per the kind order of my superior, I along with ASI Chandra Prakash Adhikeri, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, all are of Matigara PS, SPC proceeded to opposite SJDA Office, Himachal Vihar under Matigara P.S. jurisdiction to verify the source information. On 28.05.2025 at around 00:25 hrs. we arrived at near SJDA office under Matigara P.S.. Further on arriving at the exact spot as shown by the source we could hear their whispering from the distance. Accordingly we cordoned the place and approach towards them very slowly and carefully. However seeing the police party they started to flee away and somehow we managed to apprehend 03 (three) persons. During interrogation they disclosed their identity as noted above (not verified) and also disclosed that they were assembled there for making preparation to commit dacoity at Himachal Vihar area. Furthermore, They admitted that 07/08 of their associates were able to fled away from the spot. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest after observing all formalities. The search seizure were made in between 00:35 hrs to 00:45 hrs on 28.05.2025 under proper video graph.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i)- Mustak Alam @ Alex (19) S/O late Tafjul Rahaman of Jhar Bari, Chopra, P.S. Chopra, Dist. Uttar Dinajpur (2)- Md. Alim @ Ali (20) S/O Mofiz Alam of Lelin colony, P.O. & P.S. Matigara, Dist. Darjeeling and (3)- Bishal Das @ Rahul (20) S/O Suman Das of Matigara, Beldangi, P.O. & P.S. Matigara, Dist. Darjeeling and others to arrange for its investigation.
