Sub: Lodging of FIR against Shri Mantu Roy, S/o Lt. Garal Ch. Roy, Vill - Haricharanvita, P.S. Bhorer Alo, Dist. Jalpaiguri, for theft of electricity by unauthorized hooking from LT overhead line

Sir,

I, **Sri Sandeep Bhattacharya**, Divisional Engineer & Station Manager, Fulbarihat CCC, WBSEDCL, P.O. Satellite Township, District - Jalpaiguri, do hereby lodge a formal complaint against **Shri Mantu Roy**, S/o Lt. Garal Ch. Roy, resident of **Village - Haricharanvita, P.S. - Bhorer Alo, Dist. - Jalpaiguri**, for committing theft of electricity by making a direct unauthorized connection (hooking) from the LT overhead line to his residence.

On **26.05.2025 at approximately 13:15 hrs**, acting on information received from various sources regarding electricity theft, a raid was conducted at Haricharanvita by the following team:

At around 13:15 hrs, we reached the premises of Shri Mantu Roy and **found that he was illegally consuming electricity at his residence through a direct hook from the nearby LT overhead line**. The unauthorized service line, including the hooking arrangement, was immediately **disconnected**, and the following article was **seized** from the spot:

Seized Article:

One length (approx. 15 meters) of 4 sq mm PVC Twin Core cable

The seizure was carried out in the presence of the following WBSEDCL officials:

Sri Srikanta Chakraborty, Junior Engineer (Gr-I), Fulbarihat CCC

Sri Suman Das, Sr. TSH, Fulbarihat CCC

The seizure list was duly signed by the above-mentioned officials and **Shri Jhantu Roy**, brother of the accused Shri Mantu Roy.

The seizure took place between **13:15 hrs and 13:35 hrs**.

As per Section **135(1)(a)** of the **Electricity Act, 2003**, Shri Mantu Roy has committed an offence of theft of electricity and is liable for prosecution.


