With reference to above Complain letter submitted to your police station on 06.05.2025, we would like to inform you that after the midnight of 25.05.2025 at around 2 AM few people forcefully entered into our land at Bandhunagar. They threatened the security guards and forcefully erected a gumti on the said land and also put bamboo barricade in our plot of land including the entrance gate.

We had already verbally communicated this through phone call to your officer at the police station at around 2:20 AM today.

We would like to inform that in the recent visit of Chief Minister to Siliguri on 19.05.2025 at Dinbandhu Manch with the delegates of Industrial Park in which we were also invited (as our project at Bandhunagar has also been granted final approval), she had emphasized on early completion of the Industrial Parks so that the Industries can be set-up and started at the earliest to boost the economy of the North Bengal and generate employment.

We request you to kindly remove the temporary erected structures and take necessary action against those people.
