would like to lodge this written complaint to the effect that today on 28.05.2025 at about 09.15 hours, I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 1077, Date: 28.05.2025 received a source information that one Prakash Barua of Ambari is selling illicit liquor at Ambari Bazar under Bhorer Alo PS. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force of Bhorer Alo PS left for Ambari Bazaar to verify the said information in hand.

At about 09.25 hours I along with force reached at Ambari Bazar and being shown and identified by the source I along with force held raid and apprehend him. On enquiry he disclosed his identity as Prakash Barua (M/24) s/o Late Pranesh Barua of Post Office More, Ambari, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri. Further in presence of available witnesses I, along with my accompanied team searched his belongings and and found/recovered the huge amount of above noted seized liquor from his possession which he was selling in open market. On demand he could not produce any valid documents in respect of the above noted seized articles. During interrogation he stated that he has been involved in selling illicit liquor at Ambari hat Bazar without any valid license since few months for his illegal gain. The apprehended accused person has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 28.05.2025 in between 09.35 hours to 09.50 hours.

I, therefore pray before your good self that a specific case under proper section of law may kindly be initiated against the arrested accused person namely Prakash Barua (M/24) s/o Late Pranesh Barua of Post Office More, Ambari, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
