While on a routine inspection on the site having consumer id 412110933, meter no FS012948, having power connection of WBSEDCL in the name of Dulari Devi Agarwal (Ph- 9832436899) in the address being W/O Hari Kishan Agarwal, 2<sup>nd</sup> Mile Sevoke Road, Opposite Power House, Siliguri, Dist-Jalpaiguri, P.S Bhaktinagar, Pin-734001, West Bengal, I, Ranadip Mazumder, Assistant Engineer & Station Manager, Power House CCC along with Md Azharuddin, Junior Engineer, Grade-II, Power House CCC, WBSEDCL, Sri Jyotiska Sengupta, Sr. Office Executive and other technical staffs observed that the energy was being used unauthorizedly for commercial purpose at Cosmo Bazar 2<sup>nd</sup> Floor via domestic connection.

We entered the premises at 16:00 hrs on 27.05.2025 after handing over Notice to Sri Navin Jindal (son of Dulari Devi Agarwal) present during inspection. Then it was observed that the power was being used unauthorizedly for commercial purpose at Cosmo Bazar 2<sup>nd</sup> Floor via domestic connection. Therefore committing a crime for theft of power as per section 135 (1) (e) of The Electricity Act 2003 amended on 2007 of India. A maximum Demand of 18.635 KVA (15.84 KW) was found recorded in the energy meter as on 27.05.2025 and contractual load of is 8.23 KVA.
