Respected Sir/Mam,

I Smt Aloka Paul W/O Sri Manik Paul, residing at Lake Town, Near Pipe Line, P.O. & P.S. NJP, Dist. Jalpaiguri, PIN. 734007, West Bengal, beg to state you that Shubhashree Modak is residing at ground floor of our house as a tenant from 25th September 2024. At the time of Tenancy Agreement she said that she will stay with her senior citizens parents but she is living here alone. Soon we became family friends .Shubhashree Modak is running a business under the name M/S. Assurance Stuffing Solutions Pvt. Ltd. On October month she was facing financial difficulties and has an urgent need for funds for her business. She appeared me seeking financial assistance by offering a 50% ownership stake in her company. On 22nd October I agreed about her proposal of 50% partnership of her company by giving a sum of 7,50,000/- (seven lakh fifty thousand only). After that Shubhashree introduce me with a person, namely Arpeet Bhagwan(Phone number ,7359937713) regarding business purpose. With the provocation of Shubhashree, I meet him many times and a love relation grow up between us and after passing the day we got physically intimated with each other and he also approached me to marry with him. Several time we intimate and spend a good time with each other. Most of the time when we meet each other the above mentioned accused person and her boyfriend namely Samir Rajput s/o unknown present on the spot.

But after passing some days Arpeet Bhagwan avoiding me by saying that he has some family problems. Despite that the behaviour of Subhashree has been changed . Every night unknown man and woman enter into the tenant premises and doing illegal activity like drinking, shouting, play loud music in whole night . I have doubt that the man and womans are doing illegal sexual activities in my house with the influence of Shubhashree Modak (Our Tenant). I also mentioned here that shubhashree did not paid her rent properly.

One day when I went to her room and told her that this kind of behaviour will not tolerate and please clear my dues and give me proper balance sheet of the said business in which I paid hugh money , she came with dare consequences and showing me some vulgar photographs and video clips of me and Arpeet Bhagwan. Being a married woman I got afraid and requested her please don't show this to my husband, then she replied that she will not show it either at and when she required money if I give to her, for saving my matrimonial house , I agreed with her and approximately I paid her Rs. 15,00,000 /- (fifteen lakhs) by selling my gold ornaments. But her greediness did not stop here , again she demanded huge money and also told that she will reside our house for lifetime.

Finding no other alternative today morning I disclosed everything to my husband and accept my guilty, then I went to her room and asked to vacate my room she came with dare consequences and using filthy languages upon on me and when I defend her she beat me very badly and kick

me here and there , as a result I sustain grievous injury on my body, then I started shouting and my husband came and told her to leave our house, she threatened us by saying that she disclosed this photograph and video on social media, if me and my husband further asked her to leave the house. After that I went to the Siliguri District Hospital and there my treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities as because I am very much afraid by thinking that if this photograph and video clip will come out , it will hampered my dignity and I have no other option to commit suicide.
