I, Sri Manik Das, (45), A.E. & Station Manager of NJP Gate Bazar CCC, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Manoj Debnath to the effect that, on 27.05.2025 in course of inspection, myself along with Bijoy Lakra, S/O: Bernard Lakra, Divisional Engineer (Elect.), Shri Bhaben Roy, S/O: Late N.C Roy, SO, both of Darjeeling Regional office, WBSEDCL, Suren Turi, Sr. T.S.H of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Makhan Debnath at Surya Sen Colony, B Block, near Bridge Hotel, P.O: Bhaktinagar, P.S. NJP, Dist: Jalpaiguri at 14.46 Hrs. Prior entry to the premises, a notice was issued in the name of Makhan Debnath for inspection of the said premises which was received by Manoj Debnath, who was introduced himself as a Son-In-Law of Manoj Debnath and told us that he is the present user of the existing service connection as Manoj Debnath was died. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the present user of the said premises conducted inspection.

During inspection it was found that, there has one domestic connection vide consumer id: 412081660 in the name of Late Makhan Debnath in the premises, where Manoj Debnath, Son-In-Law, the present user was using electricity illegally for his commercial purpose to run a Grill factory. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 3.67 KVA. On being asked, Shri Monoj Debnath admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Manoj Debnath, S/O: Late Mahananda Debnath, Surya Sen Colony, B Block, near Bridge Hotel, P.O: Bhaktinagar, P.S.
