I, Sri Manik Das, (45), A.E. & Station Manager of NJP Gate Bazar CCC, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Prakash Chandra Saha to the effect that, on 27.05.2025 in course of inspection, myself along with Bijoy Lakra, S/O: Bernard Lakra, Divisional Engineer (Elect.), Shri Bhaben Roy, S/O: Late N.C Roy, SO, both of Darjeeling Regional office, WBSEDCL, Suren Turi, Sr. T.S.H of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Prakash Chandra Saha at village Jamurivita (Near Bhola More), PO: Sahudangihat at 13.13 Hrs. Prior entry to the premises, a notice was issued in the name of Prakash Chadra Saha for inspection of the said premises which was received by him under his signature. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the consumer/owner of the said premises conducted inspection.

During inspection in presence of the consumer it was found that, there has one domestic connection vide consumer id: 402574790 in the name of Shri Prakash Chandra Saha in the premises, where he was using electricity illegally for his commercial purpose to run a Marriage Hall. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 7.650 KVA. On being asked, Prakash Chandra Saha admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Prakash Chandra Saha, S/O: Late Haripada Saha, vill: Jamurivita (Near Bhola More), P.O: Sahudangihat, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 27.05.2025 from 13.13 hrs. to 13.30 hrs at the same premises in presence of the consumer.
