Sir,

In producing herewith one arrested accused person namely Bikram Roy (M/24) s/o Lt Jyotin Roy of South Colony, Battala, PS. NJP, Dist. Jalpaiguri along with seized articles 14 (fourteen) bottles of Himalayan Gold 60UP country spirit each bottle 600 ml as per the seizure list (which is enclosed herewith). I SI. Tanmoy Kundu of NJP PS/SPC do hereby lodge this written complaint to the effect that on 28.05.25 at around 09.25 hrs received a secret source information that one person is illegally selling liquor inside his house situated at South Colony more under PS NJP, Dist- Jalpaiguri without any valid license.

Accordingly I informed the matter to I/C NJJP PS, SPC and as per kind direction myself along with force left for the spot to verify the veracity of the information. On reaching at South Colony more and on being identified by the source, it was found that the mentioned person was selling liquor inside his house to the customers. On seeing our team the customers as well as the above noted person tried to flee away leaving the liquors bottles which was selling to the customers. But police team managed to apprehend the above noted person. On being asked to the apprehend person it came to learnt that he is the owner of the house and on interrogation, he admitted that he is selling liquor to the common customers in high price since long for his wrongful gain without any valid paper. Accordingly, in the very presence of the witnesses conducted search of the house of apprehended person, above noted liquors were recovered. Accordingly, I seized the liquors total 14 (fourteen) bottles of Himalayan Gold 60UP country spirit each bottle 600 ml under proper seizure list and labelled the seized articles duly signed by the witnesses. Seizure was made on 28.05.25 in between 10.45 hrs to 11.05 hrs and arrest the accused Bikram Roy (M/24) s/o Lt Jyotin Roy after disclosing the fact of his arrest to his guardians and ground of arrest has been communicated as per law and taken in custody. On local enquiry it came to learnt that the arrested person Bikram Roy (M/24) s/o Lt Jyotin Roy above named is runs this illegal business of liquor at his house without any valid license or permission from the appropriate authority in the close vicinity of Public Place.

Hence I request you to start a specific case under proper section of law against the arrested accused Bikram Roy (M/24) s/o Lt Jyotin Roy of South Colony, Battala, PS. NJP, Dist. Jalpaiguri and kindly arrange for its investigation.
