Accordingly, myself along with ASI Chandra Prakash Adhikary, C/219 Sanatan Chitrakar and C/868 Sujal Roy all are of Matigara PS, SPC left for Talukjote under Matigara PS to work out the information in hand. At around 17:35 hrs we arrived at Nijen store located at Talukjote of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his store/house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his Store/house located at Talukjote, P.O.
