Sir,

With due respect, I am producing herewith 01 (one) arrested accused person named Sri. Nijen Saibo (41) S/ O late Zebra Saibo of Talukjote, P.O. Nema, P.S- Matigara, Dist- Darjeeling along with following articles:- (1) Seven (07) bottles of Cosmos Fifty Delux Whisky each containing 750 ml And (2)- Five (05) bottles of Himalayan Gold 60 UP each containing 600 ml (in total 8.250 liters) as seized articles. The ground of arrest duly been communicated with him.

I ASI Pema Dorjee Sherpa of Matigara PS, SPC under your kind control beg to state that on 28.05.2025 at around 17:15 hrs. I received a secret source information that one person as noted above is selling liquor illegally from his house styled as Nijen store located at Talukjote, P.O. Nema, P.S- Matigara, Dist- Darjeeling. Accordingly, myself along with ASI Chandra Prakash Adhikary, C/219 Sanatan Chitrakar and C/868 Sujal Roy all are of Matigara PS, SPC left for Talukjote under Matigara PS to work out the information in hand. This refers to MTG PS GDE No. 2142 dated 28.05.2025. At around 17:35 hrs we arrived at Nijen store located at Talukjote of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his store/house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his Store/house located at Talukjote, P.O. Nema, PS- Matigara, Dist- Darjeeling for his illegal gain. On being search his Store/house, the above noted liquor were recovered. On demand he failed to produce any documents/license in respect of store/sale of the liquor which were recovered from his Store/house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities. The whole process of search, seizure, label & arrest was made in between 17:45 hrs to 18:15 on 28.05.2025 under video graph. The video was done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely named Sri. Nijen Saibo (41) S/ O late Zebra Sabo of Talukjote, P.O. Nema, P.S- Matigara, Dist- Darjeeling and arrange for its investigation.
