With due respect, I am producing herewith 01 (one) arrestedSacrusation Section 1 Sir. Dhiraj Shaw @ Bappa (24), S/o- Lt. Sagar Shaw of Shaktinagar, W/No. 8, PS- Raiganj, Dist- Uttar Dinajpur under arrest. The ground of arrest duly been communicated with them and the following articles under seizure :-

- 01 (One) Improvised small fire arms one shooter measuring approx 9 inches from butt to barrel with one trigger, striking hammer, striking pin, wooden butt in working condition Marked as "Exhibit-"A".
- 02 (two) live ammunition marked as Exhibit-"B". (ii)

I, ASI Chandra Prakash Adhikari of Matigara PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 28.05.2025 at 19.25 hrs, received a secret information that one person is loitering at near Chandmoni T. E. Primary School under Matigara PS with improvised fire arms and ammunition to deliver the same to his designated customer. Accordingly, I informed the matter to I/C, Matigara PS, SPC and as per his direction, at about 19.40 hrs, myself along with ASI Bikash Roy, C/219 Sanatan Chitrakar, C/868 Sujal Roy all of Matigara PS, SPC left for above noted place to work out the information in hand by Govt. vehicle vide Matigara PS GDE No. 2148, Dated- 28.05.2025 and Matigara PS MCC No. 2401/25, Dated- 28.05.25. At about 19.50 hrs we reached at the spot Le near to Chandmoni T. E. Primary School and waiting for the target. After a little while, as per source indication, I detained the above noted person and on being asked he disclosed his identity as noted above. Immediately, I searched the above noted person and found (i) 01 (One) Improvised small fire arms one shooter measuring approx 9 inches from butt to barrel with one trigger, striking hammer, striking pin, wooden butt in working condition and (ii) 02 (two) live ammunition from the possession of the said person. He exclusively possessed improvised fire arms and live ammunition illegally. On demand he failed to produce any valid document in support of the said improvised fire arms and live ammunition which has been found from his possession. On further interrogation he stated that he was there for deliver the same to his designated customer for his wrongful gain. Thus his involvement in carrying and possessing illegal fire arms and live ammunitions was established. Accordingly, I seized the improvised fire arms and 02 (two) rounds of live ammunition under proper seizure list duly signed by him as well as by available independent witnesses and arrested the apprehended accused person after issuing memo of arrest informing him about the ground of arrest. The whole processes of search, seizure, label and arrest was made in between 20.10 hrs to 20.50 hrs on 28.05.25. The seizure was made under proper video graph.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the accused person named Dhiraj Shaw @ Bappa (24), S/o- Lt. Sagar Shaw of Shaktinagar, W/No. 8, PS- Raiganj, Dist- Uttar Dinajpur is desperate and dangerous in nature, as he was carrying the said fire arms for his illegal gain.
