Ltd. Siliguri, West Bengal @ Rs 160 each (Amounting of Rs 160/- x 11 =RS.1760/-) marked as Exhibits-A ,ii) 01 (one) sealed Bottle of Himalayan Gold 60 up country spirit each containing 600 ml labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 160 , Amounting of Rs 160/- in which was taken out from mother packet box for examination as sample, marked as Exhibits-A1 as per seizure list.

I, ASI Debasish Das of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely namely Pinki Biswas (34 yrs) W/O Shibu Biswas of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 28.05.25 at 13.06 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally in her house situated at Sarbohara Colony, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no.1719 dated 28.05.25 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Rabin Lama, C/160 Soumen Sarkar and LHG/ 471 Bharati Biswas both of Siliguri PS left for Sarbohara Colony under Siliguri PS to verify the veracity of the information vide Siliguri PS G.D.E No.1720 dated 28.05.25. On reaching at 13.20 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, she disclosed her identity as noted above. On being asked she stated that she used to sale the 80 up Country Spirit to locality without any valid documents. On being asked she could not produce any valid documents in respect of the said liquor. On searching vize i) 11 (Eleven) sealed Plastik Bottles of of Himalayan Gold 60 up country spirit each containing 600 ml.

Ltd. Siliguri, West Bengal @ Rs 160 , Amounting of Rs 160/- in which was taken out from mother packet box for examination as sample, marked as Exhibits-A1 and accordingly I seized the same as per seizure list as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. She also stated that she is doing this liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 13.45 hrs and 14.15 hrs. As such I arrested her U/S-35(1) BNSS after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Pinki Biswas (34 yrs) W/O Shibu Biswas of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
