Respected Sir,

I Bikram Saha, S/O Lt. Basudev Saha, resident of Sharat Chandra Pally, Ward No.: 40 of SMC, PO: Haider para, PS Bhaktinagar, Dist Jalpaiguri, would like to draw your very attention on a serious incident to the very effect that on 27/05/2025 at around 9:25 pm at Kamal tailor more, Sharat Chandra pally, Haider para ward no.40, Siliguri when I along with our brothers namely 1)Rahul Sarkar S/O Bibek Sarkar, 2) Rahul Saha S/O Ram Prasad Saha, 3) Akash Saha S/O Asit Saha were gathered near to my house i.e. near to Kamal tailor more, Sharat Chandra pally, Haider para ward no.40, Siliguri for interaction, 10-15 unknown miscreants under the leadership of 1) Rakib Alam and others of Ashraf Nagar, ward no.40 suddenly arrived at the spot and gheraoed us and demanded money and other valuable articles available with us under extorting manner. It is right place to mention here that these miscreants under the leadership of the above persons, used to do criminal activities at Ashraf Nagar and its surrounding region. Thereafter on our refusal, they attacked upon us with deadly weapons viz. Sharp knife, Iron rods, Wooden sticks etc. and out of their said merciless deadly attack of killing us, I had received an injury to my left collar bone, said Rahul Saha has sustain a injury in his hand, Rahul Sarkar received fractured injury at right wrist, Akash Saha has got hurt on his left leg. On our shout during such attack upon us, my mother namely Beauty Saha rushed at the spot and tried to resist them, but they also intentionally outraged the modesty of my mother at public road and also snatched the gold neckless of my mother. Moreover they took all cash i.e. altogether a sum of Rs. 35,700/- from all of us. Thereafter on our shout, when local people along with our well wishers came at the spot, then after addressing filthy languages to each of our end and giving continuous dire consequences they left the spot. We had been medically treated under emergent manner.

They did attack upon us with every intent of attempt to kill us and also did fatal injury under voluntary manner and there is every apprehension of life threat existing to us due to their very desperate attitude and the same need to be resisted with strong measures. Due to health issues of the

said attack as well as mental panic, the delay caused to file the present complaint and right now under sound mental strength, I am filing this complaint before your very end.

So it is therefore requested to take appropriate legal action/s against the above Rakib Alam and his miscreants under immediate manner for the proper administration of Justice.
