With due respect and humble submission I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against one lady namely Kalsang Choedong W/o Jamyang Yeshe of Salugara Bazar, Near Vegetable Market, PO Salugara, ward No-42, PS Bhaktinagar Dist Jalpaiguri to the effect that on 28.05.25 at 14.45 hrs while performing PS Special van duty received a source information from Salugara Bazar under Bhaktinagar PS that one lady named Kalsang Choedong W/o Jamyang Yeshe of Salugara Bazar, Near Vegetable Market, PO Salugara, ward No-42, PS Bhaktinagar, Dist Jalpaiguri has gathered huge quantity of liquor in her Restaurant style as "Norling Fast Food" at Salugara Bazar for selling the same in the open market for her wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1446 dated 28.05.25. As per your kind instruction immediately myself along with ASI Dhurbo Misra, LASI Urshula Lalbegi, and C/374 Debraj Biswas proceeded to the PO to work out the information. Within 30 minutes we reached at the spot, sometimes after, being identified by the source our police party held raid and seeing the Police party the above noted lady fled away from the her shop. On hot chase by lady police personal failed to arrest her but recovered and seized the following articles from her Restaurant at Salugara Bazar under Bhaktinagar PS:-

- (1) 08 (Eight) bottles of KINGFISHER imperial strong beer (each bottle containing 650ML)
- (2) 02(Two) bottles of TUBORG premium beer (each bottle containing 650ML)

During local enquiry it came to learn that the name of alleged lady is Kalsang Choedong W/o Jamyang Yeshe of Salugara Bazar, Near Vegetable Market, PO Salugara, ward No-42, PS Bhaktinagar Dist Jalpaiguri. She is selling the same in open market since long for her wrongful gain without any valid documents/license. In presence of witnesses namely (1) Shyamal Roy S/o Lt. Prabin Roy of Salugara Bazar, Near Durga Mandir, ward No-42, PS Bhaktinagar Dist Jalpaiguri (2) Rajib Gurung S/o Maila Gurung of Salugara Bazar, Near Vegetable Market, PO Salugara, ward No-42, PS Bhaktinagar Dist Jalpaiguri and (3) LASI Urshula Lalbegi of Bhaktinagar PS/SPC, I seized the above noted articles from the PO (The seizure was made in between 15.25 hrs to 15.55 hrs) after preparing proper seizure list duly signed by them. The whole search and seizure process was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused lady Kalsang Choedong W/o Jamyang Yeshe of Salugara Bazar, Near Vegetable Market, PO Salugara, ward No-42, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
