Sir,

With due respect I Rupali Roy (Debnath), W/o Mithun Debnath, D/o Bimal Roy, presently residing at C/o Sanjib Saha, Kalisaha More, Ghogomali, Ward No: 38, P.O – Ghogomali, P.S – Ashighar, Dt – Jalpaiguri (Permanent Address – Madarihat, Ashini Nagar, Ward No: 1, P.O + P.S + Dt - Alipurduar) do hereby wants to state you that on 8th May 2020 I have undergone marriage with Mithun Saha, S/o Arun Debnath resident of Baxirhat, Bhanukumari, Subashpally, Dt – Coochbehar but presently residing with me at C/o ^{D/PU} Sanjib Saha, Kalisaha More, Ghogomali, Ward No: 38, P.O – Ghogomali, P.S – Ashighar, Dt – Jalpaiguri. After the marriage all my in-laws together with my in-laws started torturing me both physically and mentally they are Father in law – Arun Debnath, Mother in law – Sarala Rani Debnath, Brother in law – Chotan Debnath and Bijay Pandit, Sister in law – Swapna Kundu all this accused person have physically abused me mercilessly. Thereafter finding no other way I and my husband came to Siliguri and started residing here. I have also got a baby namely Soumodeep Debnath who is now 2 years old. My husband has got a rented mobile shop in Ghogomali, Siliguri.

That at the time of lockdown that is on 2020 I have came across to my husband through social media thereafter we came close to each other and from that time my husband and all my in laws pressurising me to get married with my husband. Therefore we got married and after the marriage I came to know that my husband is already a married person. He has got already a wife but he haven't took any divorce and he married me in support of all this family members. That when I objected this matter then all my in laws and my husband started torturing me. They used to keep me alone and does not let me enter into the room. I used to sleep in veranda. All house hold work is being done by me day and night. When I take rest all my in-laws comes and hot me with kicks and blows. I was not given mobile to contact with my parents. I was not given proper food to eat and I also

was not given proper clothes to wear. My in-laws used to beat me with iron rod, wooden stick, blows, kicks but not any time attend me to doctor.

That on 2021 I and my husband came to Siliguri. Here I gave birth to my baby. After the birth of my baby my husband torture increases. He comes late at night in a drunken position and started hitting me with wooden stick, belt, kicks and blows. He never took me to doctor my neighbour used to take me to doctor. On 7/5/2025 at about 1:30 AM my husband started bitting me and made physical assault. That time all my in-laws are over phone and instigate my husband to kill me. My husband took the pillow kept over my mouth and tried to kill me. Even same thing done to my 2 years son. When I trued to stop my husband took belt and started bitting me and through his blows, I got physical hurt over my eyes and over my head.

That my husband several times have done this torture to me a and also towards my child. My husband used to bring some other men at home and asked me to entertain then all when I object this matter, he started hitting me infront of them. My husband on one occasion dashed my head over the wall where I was seriously injured and got fainted. My husband used to throw my child in the floor so that he dies. My husband is going all this thing with a reason that I and my child should leave him and together with in laws he will marry again in Siliguri.

Now my husband has already got many love affairs with different girls including below 18 years also and also have dome physical relation with then. My husband has got no fear of law and order when I tried to call police I was bitten heavily and take over my phone even my husband has stolen an amount of Rs 70,000/- (my job salary savings) together with my gold ornaments and sold them all and used to drink alcohol and takes medicine which my husband becomes more ferocious. Not its impossible for me to stay with my husband at any time my husband can kill me and my small baby also.

I have also gone to Siliguri hospital for medical check up where the doctor has stated that it's a police case and I have also given t letter about this to the ward councillor who have also suggested to register an FIR in the police station. I was thrown out from house I and my baby is sleeping outside rented house I am leading a very pathetic life not give food for 3 to 4 days.

Therefore I request you to start an investigation against my husband and all in-laws and also to start a specific criminal case for their acts and deeds for the

ends of justice and also to put them behind bars for punishment to provide me natural justice which I am praying before you.
