
I, Biswajeet Bhowmik s/o Lt. Bishnu Pada Bhowmik, resident of Bottle Company more, Siliguri, would like to lodge a serious complaint against Mr. Rajen Das (Phone: 9851003011) resident of Swapna Neer-1 Apartment, 3rd Floor, Ghoogni more, Haider Para, Siliguri for physically assaulting and threatening me in public.

Today, while I was returning from Lower Bhanu Nagar after dropping my son off for private coaching, Mr. Rajen Das, suddenly confronted me near Nanglo Bar, Upper Bhanu Nagar, Sevoke Road, ward no-43, Siliguri. Without provocation, he started beating me forcefully in my stomach and chest and dragged me on the road. While assaulting me, he angrily questioned why I had lodged a complaint at NJP Police Station regarding the theft of PVC pipes.


These PVC pipes were removed without my consent by Ms. Monidha Doley (Phone: 7025939518), a staff member of NEECON – the contractor working for NRL Rangapani. The pipes were reportedly sold to Mr. Md. Taful at Gora More. The money obtained from the sale was allegedly shared between Rajen Das and Monidha Doley.

Following the roadside assault, Rajen Das dragged me inside a nearby hotel (Nanglo Hotel), continued to threaten me with dire consequences, and used abusive and filthy language, including derogatory remarks about my deceased parents.

This is a grave threat to my life and dignity. I request immediate and strict action against the accused under relevant sections of the IPC.
