With due respect and humble submission I ASI Kanak Das of Matigara P.S, SPC do hereby lodge this written complaint to the effect that today on 29/30.05.2025 I was deputed to perform K-33 Mobile Van duty along with force w.e.f 22;00 hrs (30.05.2025) to 08;00 hrs. (30.05.2025) vide Matigara P.S. C.C. No.2404/2025, Dated-29.05.2025 & Matigara P.S. GDE No.2166/25, Dated-29.05.2025. At about 01:05 hrs in course of said Van duty I received source information that one Six wheeler vehicle (Tata Truck) is coming from Mahananda River towards Binay Krishna Pally Near Ram Ghat Bridge under PS-Matigara loaded with river bed materials which were procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to the spot and found one Six wheeler vehicle (Tata Truck) bearing Regi. WB-76 2170 coming from Mahananda River side loaded with river bed materials. We managed to detain the vehicle at Binay Krishna Pally Near Ram Ghat Bridge under Matigara PS. On seeing the Police team the driver /owner of the vehicle (Tata Truck) fled away from the vehicle. I searched the driver and any valid documents in respect of loaded river bed materials but no any document or the driver could be found nearby. Finding no other alternatives, I seized the said Six wheeler vehicle Tata Truck bearing Regn. No. WB-76 2170 loaded with river bed materials under proper Seizure List under coverage of Videography in abandoned condition in presence of witness in between 01:15 hrs to 01:25 hrs. and brought the seized vehicle at P.S
